APPLICANT ACKNOWLEDGES TO HAVE READ, UNDERSTOOD AND AGREED TO ALL THESE TERMS WHEN HE/SHE CLICKS "I AGREE" BUTTON OR AN EQUIVALENT INDICATOR THERETO.

- i. All Applicants should be in possession of a passport which have a minimum validity of six month and which has not less than one unused Visa page before Visa application submission;
- ii. Applicants who do not possess their national passports, must indicate their type of passport in the respective field within online application;
- iii. Each Applicant is required to select the right type of Visa. Applying for a wrong type of Visa may lead to rejection;
- iv. Ensure all supporting documents for a particular type of Visa are uploaded in the online application. All Visa application requirements are calculated based on general criteria and can vary due to various factors including but not limited to the information provided by the applicant;
- v. Applicants are required to lodge Visa applications ten days before their expected date of travel and two months for those persons and applicants whose countries fall under referral Visa category;

- vi. Once the online application form is submitted by the applicant, further modifications are not allowed. Hence applicants are requested to check and validate the details before submitting the online application form;
- vii. In case of Visa rejections, the Immigration Service Department holds the right to give or withhold reasons for rejection to the applicant;
- viii. In case a Visa approval / Grant notification has been issued, the applicant cannot make a request for such approval to be postponed or change the dates stipulated therein for its validity;
- ix. The applicant is not expected to arrive to the United Republic of Tanzania before his / her visa application being approved. If for any reason the applicant arrives before such approval, he / she may be subjected to pay a non - refundable respective Visa fee;
- x. Upon Visa Grant, an applicant is issued with a Visa Grant Notice which specifies Visa start date and Visa end date, which the holder is required to observe;
- xi. Visa Grant notification is not the final authority to enter the United Republic of Tanzania as it is the Immigration Officer at the entry point who has the final authority on entry decision based on reasonable grounds;

### **Non Refund Policy**

All Visa fees are pre-paid, non-refundable and non-transferable. The non-refundable policy applies in all and not limited to the following circumstances;

1. Upon rejection/denial of the Visa application.
2. Upon cancellation of the Visa application after submission by the applicant's own cause.
3. Upon travel cancellation or postponement by the applicants own due cause after being issued a Visa approval/grant notification.
4. Upon double payment when the applicant submits another Visa application of the same respect or of a different type of visa before the first Visa application submitted has been processed.
5. Upon double payment when the applicant arrives before his online visa is approved, and the Immigration Officer at the entry point subjects him/her to pay Visa on arrival.
6. Upon not receiving a Visa Grant notification in his/her email. NB: Applicants are advised to track the progress of their applications online by using their credentials which they submitted while filling the visa application form.
